



## MISS GAY TEXAS STATE PAGEANT SYSTEM BYLAWS

### ARTICLE I - NAME, PURPOSE

Section 1: The name of the organization shall be Miss Gay Texas State Pageant System.

Section 2: The Miss Gay Texas State Pageant System is a 501(c) 4 Non-Profit Organization. Its purpose is to develop and maintain a high-quality and professional pageant system and be recognized as the "Symbol of Excellence" within the community the pageant serves. The System also supports and promotes men who take the art of female impersonation to a higher level. Annually the system will donate funds back to the community when available.

### ARTICLE II - MEMBERSHIP

Section 1: Membership shall consist of the members of the Executive Board of Directors (EBOD), Consultants and Advisors as deemed necessary.

### ARTICLE III - ANNUAL MEETING

Section 1: Annual Meeting. The date, time and place of the regular annual meeting shall be set by the EBOD. Attendees include newly crowned titleholders and the EBOD.

Section 2: Special Meetings. Special meetings may be called by the Chairman or the Executive Board, (Chairman, Vice-Chairman, Secretary & Treasurer).

Section 3: Notice. Notice of each meeting shall be given to each voting member, by mail, email, or text messaging not less than ten days before the meeting. (See Article 5, Section 1, Letter B)

### ARTICLE IV – CO-FOUNDERS

Section 1: Co-Founders shall be known as Bill Lindsey and Michael Champion.

### ARTICLE V – EXECUTIVE BOARD OF DIRECTORS

Section 1: Board Role, Size, Compensation. The Executive Board is responsible for overall policy and direction of the Pageant System, and to delegates responsibility for day-to-day operations to the BOD and Committee Chairs. The BOD receives no compensation other than reasonable expenses.

A) Officers and Duties. There shall be four officers of the Executive BOD consisting of a Chairman, Vice Chairman, Secretary and Treasurer. Their duties are as follows:

The **Chairman** shall lead regularly scheduled BOD meetings. Should the chairman not be present, other members of the executive board will preside in the following order: Vice-Chair, Secretary and Treasurer.

The **Vice-Chairman** will chair committees on special subjects as designated by the board; ensure bylaws are current, and rules and regulations are followed.

The **Secretary** shall be responsible for keeping records of BOD actions, including overseeing the taking of minutes at all BOD meetings, sending out meeting announcements, distributing copies of minutes and the agenda to each BOD member, and assuring that corporate records are maintained. Work with advertising to ensure promoter and public relations material are available. All minutes and announcements must be distributed within 7 days.

The **Treasurer** shall make a report at each BOD meeting. Treasurer shall chair the finance committee, assist in the preparation of the budget, help develop fundraising plans, and make financial information available to BOD and the public

1) The Treasurer shall: ascertain and administer the receipt, maintenance, and completion of the following Tax Authority Requirements

- a) State Franchise Tax – due May 15<sup>th</sup> each year (prior year's gross receipts)
- b) IRS form 990 or 990EZ – due no more than give (5) months following completion of fiscal year.

2) Currently the Treasurer position is held for life.

B) Other Titles of the BOD. Event Coordinator, Director of fundraising and sponsorship, Current Titleholders; Consultants, Scoring Specialist, Publication/Design, and other titles can be assigned as deemed necessary by the BOD.

Section 2: Meetings. The BOD shall meet at least once per quarter, at an agreed upon time and place.

Section 3: Board Elections. Election of a new board will occur as the first item of new business at the annual meeting of the corporation. Members will be elected by a majority vote of the current EBOD.

Section 4: Terms. Board Members shall have no specific length of term.

Section 5: Quorum. A quorum must consist of at least 50 percent plus one of the EBOD before business can be transacted or motions made or passed.

Section 6: Officers Election and Terms: Officers will be nominated and voted on after new BOD members are approved in new business at the annual meeting. Chairman & Secretary occur every (even) year and Vice Chairman every (odd) year.

Section 7: Vacancies of Officers. When a vacancy for an Officer exists, nominations and voting will be at the next regularly scheduled BOD meeting.

Section 8: Resignation, Termination and Absences. Resignation from the BOD must be in writing and received by the Chairman. All Board members are subject to the Code of conduct as outlined in the bylaws. A BOD member may be removed for any reason by a three-fourth vote of the remaining directors. (EBOD)

## **ARTICLE VI - COMMITTEES**

Section 1: The EBOD may create committees as needed. The BOD Chairman appoints all committee chairs.

Section 2: The Executive BOD shall have all the powers and authority in the intervals between meetings subject to the direction and control of the BOD.

Section 3: Finance Committee. The Treasurer is Chair of the Finance Committee, which includes Director of Fundraising and Sponsorship, and Event Coordinator. The Finance Committee is responsible for developing and reviewing fiscal procedures, a fundraising plan, and annual budget with other BOD members. The BOD must approve the budget, and all expenditures must be within the budget. Any major change in the budget must be approved by the BOD. The fiscal year shall be from October to September. Reports are required to be submitted to the BOD showing income, expenditures and pending income. The financial records of the organization are public information and shall be made available to the public after it has been verified and approved by the BOD.

## **ARTICLE IX- CHARITY BENEFICIARY**

Beneficiary will be chosen by the Co-Founders and announced at the State Pageant.

## **ARTICLE X - AMENDMENTS**

Section 1: These Bylaws may be amended, when necessary, by a two-thirds majority of the EBOD. Proposed amendments must be submitted to the Secretary to be sent out with regular BOD announcements. These Bylaws were approved at a meeting of the BOD.

## Appendix A

### Promoters Rules and Regulations

Definition of a Promoter: A Person or Company that finances and organizes an event or production.

- 1) All Promoter actions, advertisements, and commitments must be approved by the Chairman or Vice Chairman prior to the preliminary or event.
- 2) Promoter commits to the format set by the BOD governing the Miss Gay Texas State Pageant System.
- 3) Create a plan to be innovative with the theme, secure a venue, acquire contestants, to promote and host your preliminary pageant or event, and adhere to the criteria based on the Rules and Regulations of the Miss Gay Texas State Pageant System.
- 4) All advertising must have specific details to be submitted and approved by the Chairman or Vice-Chairman. Details must include date, time, categories, entry fee, prize package, and theme.
- 5) All advertising must begin a minimum of 30 days prior to the event or preliminary
- 6) There must be a minimum registration deadline for contestants of at least 5 days before the pageant prelim.
- 7) By signing the Promoter Agreement, you are bound contractually to provide the listed items and details written.
- 8) Preliminary Fees - Total price as a Preliminary Promoter is \$450, not including any booking fees. This includes the two Preliminary Crowns and official sashes for winners, and admission to the State Pageant for both the State Winner, At Large Winner, and the 1st Alternate of each. (No alternative sashes are permitted.) All fees must be paid on or before 30 days prior to the date of the Preliminary and will be collected by the Board Treasurer. All fees are non-refundable.
- 9) Reigning Miss Gay Texas State and at Large are required to perform at each preliminary. Their booking fee is \$125 each for a minimum of 2 performances and assistance with the preliminary as the promoter deems necessary (within reason) Payment to be paid prior to the start of the preliminary. Titleholders are required to follow the Code of Conduct.
- 10) Preliminaries 100 miles or greater outside the DFW area will require Travel Accommodations for the State Title Holders as they deem necessary and within reason but not to exceed hotel lodgings and transportation expenses. All preliminaries must be held not to exceed 50 miles outside of the state line.
- 11) Promoters are encouraged to attend, promote, and support other Miss Gay Texas State Pageant System Events, and encourage their titleholders to do the same.
- 12) Failure to follow Rules and Regulations will result in elimination of preliminary and/or Event and removal from the Miss Gay Texas State Pageant System. All Rights to preliminary name will be forfeited upon expulsion from The Miss Gay Texas State Pageant System.
- 13) In the event there are no contestants, the preliminary owner may choose to send their reigning titleholders to the state pageant or first alternates to the state pageant.
- 14) Promoter Conduct – All promoters will be required to abide by the Code of Conduct and rules 11-17 on Contestant Rules (page 6-7)
- 15) Pageant Preliminary Categories – Preliminaries must be operated in the same format as the State Pageant, including Presentation, talent, Evening Gown, On-Stage Q&A, with the exception of Person Interview, which will be at the promoter's discretion.

Remember, all members of the Miss Gay Texas State Pageant System are ambassadors and available to assist you in your success. Preliminaries will deliver results based on the work that is put into them. We appreciate your willingness to become a Promoter, and we encourage you to leave your mark within the Miss Gay Texas State Pageant System.



## Promoter Agreement

As the Preliminary Promoter, it is your responsibility to comply with the Promoter Rules and Regulations as set by the BOD of the Miss Gay Texas State Pageant System. The Miss Gay Texas State Pageant System accepts no responsibility for any agreements or actions between contestants and the Preliminary Promoter. All agreements should be in writing and acknowledged between the Promoter and Contestants.

All preliminary pageants must be scheduled at a minimum of 30 days in advance and will occur even if you have only one (1) Contestant. The Miss Gay Texas State Pageant System will provide judging criteria that must be adhered to. Copies of all judge's sheets should be retained for review, if necessary. All Preliminaries should be scheduled with the Chairman or Vice Chairman and reigning Miss Gay Texas State and State at Large for guest appearance and oversight.

Each Preliminary Promoter is expected to follow and enforce the written rules and regulations of the Miss Gay Texas State Pageant System, governed by the Executive Board. This agreement is good for one calendar year from the date signed.

As a promoter you are leasing the name of the preliminary pageant. Should you decide not to continue or are removed as a promoter, ownership of the preliminary pageant will remain with the Miss Gay Texas State Pageant System.

**Approval will be at discretion of the Miss Gay Texas State Pageant System Executive Board of Directors.**

## Appendix B

### THE PRELIMINARY MISS GAY TEXAS STATE PAGEANT SYSTEM RULES AND REGULATIONS

**Any and all Preliminary Pageants are an official Preliminary to Miss Gay Texas State Pageant System**

#### **Mission Statement:**

The Miss Gay Texas State Pageant Systems' purpose is to develop and maintain a high-quality and professional pageant system and be recognized as the "Symbol of Excellence" within the community the pageant serves. The System also supports and promotes men who take the art of female impersonation to a higher level. Annually the System will donate funds back to the community, when available.

#### **Definitions:**

- 1) Preliminary or Prelim: a contest or pageant that precedes the State Pageant and produces a State and State at Large winner.
- 2) Promoter(s): one who assumes the financial responsibilities of and including contracting with the Board of Directors, Securing the venue, advertisement, and collecting entry fees.
- 3) Contestant(s): one who competes in a preliminary for the State Pageant and has permanent residency in the State of Texas
- 4) State: Any contestant that meets the criteria of MGTSPS as defined in #1 of the pageant & contestant rules.
- 5) At Large: Any contestant that is 6 ft or taller and/or weighs 200 lbs. or more and meets the criteria of MGTSPS as defined in #1 of the pageant & contestant rules
- 6) Affiliates: assistants, friends, dancers, dressers, makeup artists, entertainers, partners, family, or any other person that is with the contestant
- 7) Format: all pageant prelims will have scored categories include Presentation, Evening gown, Talent, and On-stage question, with the option to the promoter of holding Personal Interview.
- 8) Out of Town: Any location outside the DFW area
- 9) Out of State: within 50 miles of state line

## State Contestant Rules

1. All contestants **must be biologically male** and have no breast implants, hormone enhanced breasts, cosmetic or body enhancing implants below the neck and be at least 21 years old prior to the preliminary competition. Proof of age, such as a driver's license and/or state issued identification card, passport, must be provided, if requested. If no validation is presented, the contestant will be disqualified.
2. Contestants that wish to run for an At Large preliminary must be at least 6ft tall (out of heels) and/or at weigh at least 200 pounds. and adhere to Rule #1.
3. Contestants will be judged in the following categories: Presentation, Personal Interview, Evening Gown, On Stage Question & Answer, and Talent.
4. Judging will be based on a total points-accumulated system. In the event of a tie, the winner will be determined by the highest talent score. If there is a tie in the talent scores, the tie must be broken by an onstage question involving the top 2 finalists.
5. Presentation theme will be determined each year by the current state titleholders.
6. Talent performance will be limited to 7 minutes, with an additional 2-minute prop set up, and 2-minute prop tear down allowed. Presentation and Evening Gown will be both limited to 2 minutes, and Personal Interview to 7 minutes. Props for presentation are allowed only if brought on and off by the contestant with no additional setup time.
7. Contestants should consider their talent appropriate for all members of the audience. Talent shall not cause harm or injury to contestants or others or contain offensive content. Use of projectile props is prohibited. **NO PYROTECHNICS** are permitted (fire, flash pots, flaming batons, etc.). The use of real or authentic looking weapons is prohibited. Liquids of any nature are prohibited. Fog machines, if used, must be ones provided by the venue. Any containers used must be dry. Any containers that have labels related to "Alcohol" must be cleared through the facility owner prior to entrance. This relates to TABC rules. All items used in any act must be cleaned up immediately or administrative points will be deducted from the overall score.
8. Contestants are to wear an evening gown for the crowning ceremony.
9. Each contestant will be permitted one (1) assistant in the dressing area at any given time and will be required to have a pageant issued badge. Only one assistant may be admitted at no charge all other dressers, dancers, talent performers and all others must pay the door admittance fee. Dancers will be allowed backstage to prepare 2 numbers prior to their performance.
10. All Winners and 1<sup>st</sup> Alternates **MUST** compete at Miss Gay Texas State Pageant. Any Winner who does not compete at Miss Gay Texas State Pageant may be banned from the System for one (1) year and will not be permitted to be involved in any Miss Gay Texas State Pageant functions or preliminary pageant held during the year, at the discretion of the BOD. All prizes including, but not limited to, cash, crowns, and awards must be returned to the promoter. Any preliminary winner who is unable to attend the state pageant due to work or health restrictions **MUST** notify their promoter and BOD a minimum of 30 days prior to the state pageant. **The Miss Gay Texas State Pageant System is not responsible for any agreement between the promoter and contestant.**
11. The abuse of controlled substances or the dispensing of any controlled substances will not be tolerated. Should any activity occur, the individual will be immediately dismissed and any "state title" may be removed by action of the Executive BOD. Any two (2) Executive Board Members may act on behalf of the board in its entirety.
12. Excessive use of alcohol to the point of perceived "public intoxication" or any inappropriate conduct will not be tolerated. Any two (2) Executive Board Members may act on behalf of the board in its entirety. Any further offenses will be handled on a case-by-case basis with reprimand executed by the BOD up to and including removal of title.

13. Any contestant or their affiliates caught in the act of stealing and/or causing damage to another contestant's property will be immediately disqualified and removed from the pageant location.
14. All former titleholders in violation of rules #11, #12 and/or #13 regarding controlled substances, public intoxication and or theft at any state function who have already been reprimanded and are in violation of those rules can be subject to being banned from the pageant system.
15. Anyone, including contestants and their affiliates, who cause a disturbance of **any kind** during a preliminary pageant or at the Miss Gay Texas State Pageant may be disqualified or have administrative points deducted, and could be banned from all future events. We expect all contestants and their affiliates to behave in a professional manner. Any two (2) Executive Board Members may act on behalf of the board in its entirety.
16. Smoking, food, or drink will not be permitted in the dressing areas at any pageant competitions.
17. Anyone, including, but not limited to contestants, assistants, dancers, etc. caught badgering, bullying or belittling any contestant, any judge, any member of the Miss Gay Texas State Pageant System or any affiliates may be immediately disqualified.
18. Contestants must compete at the State pageant in the division they competed in at the preliminary. Winners of a preliminary may not compete in another preliminary during the current pageant season. 1<sup>st</sup> Alternates are permitted to compete in another preliminary, if they so choose, with the understanding that they forfeit their first alternate status and cannot reclaim it.
19. The current / reigning Miss Gay Texas State and State At Large winner may not hold or seek other titles during the reigning period. After their reign winners of the Miss Gay Texas State and State At Large pageant will be permitted to run in another pageant system of their choice after their step down within 18 months (not to exceed \$125.)
20. The Miss Gay Texas State Pageant System is not liable for **personal** fundraising by any prelim titleholder and/or 1<sup>st</sup> alternate. Anyone who conducts a fundraiser under the MGTSPS umbrella and fails to participate in the state pageant must release all funds to the MGTSPS or be subjected to a 1-year ban from the MGTSPS.
21. If a titleholder is found at fault for violating the By-laws, Rules and Regulations, and/or Code of Conduct, disciplinary action will be as follows:
  - a. 1<sup>st</sup> violation – verbal warning
  - b. 2<sup>nd</sup> violation – written warning
  - c. 3<sup>rd</sup> and final violation – removal of crown and title. All winnings including money, jewelry and sash must be returned in the condition it was received to the Board of Directors within 72 hours.

## Administrative Point Deductions

<b>50 points</b>	Drinking or eating in the dressing room
<b>50 points</b>	More than one dresser in the dressing room
<b>25 points</b>	Failure to clean up stage
<b>25 points</b> (per category)	For lineup tardiness including Check-In (Saturday and Sunday), Presentation, Evening Gown, Personal Interview and Talent all at specified times.
<b>25 points</b>	Deadlines: application, talent music and crowning music submissions
<b>50 points</b>	Talent Time Violation (includes talent set up and tear down)
<b>100 points</b>	Misconduct contestants and their affiliates.

ALL ADMINISTRATIVE POINT DEDUCTIONS WILL BE DEDUCTED FROM THE OVERALL TOTAL SCORE. THE BOD HAS THE RIGHT TO ADMINISTER POINT DEDUCTIONS FOR ANY VIOLATION OF THE CODE OF CONDUCT OR PAGEANT RULES.

## Preliminary and State Pageant Prizes

### Preliminaries:

Winner of Preliminary: (Covered by Promoter Fee)

- a. Crown and Sash on the night of the pageant
- b. Paid Entry to Miss Gay Texas State and State at Large Pageant System

First Alternate of Preliminary: (Covered by Promoter Fee)

- a. Paid Entry to Miss Gay Texas State and State at Large Pageant System

**NOTE: Any other prize packages are strictly the Promoter's responsibility. See Promoter Rules and Regulations.**

### State Pageant:

Winner of State Pageant System (State and State At Large)

- a. Monetary award upon winning (see #4 under Contestant Requirements)
- b. Monetary award after completion of 1<sup>st</sup> & 2<sup>nd</sup> benefit show
- c. Monetary award upon stepping down
- d. Crown the night of the pageant
- e. Plaque, Trophy or Certificate of some nature
- f. Other items as agreed on by the BOD
- g. Paid Entry to compete in another pageant system of their choice (not to exceed \$125.) within 18 months of stepdown.
- h. A \$125.00 fee will be paid to each State winner for each preliminary they attend. This fee will be paid by the preliminary promoter and not the MGTSPS.

First Alternate of State Pageant System:

- a. Monetary award upon winning
- b. Plaque, Trophy or Certificate of some nature.

I expressly agree that (except as may be prohibited by law), my use of the services offered is at my sole risk, the services are provided on an "as is" and "as available" basis. The Pageant System makes no representation that the services so offered would meet my requirements, or would be uninterrupted, timely or error-free, or that the quality of services would be as expected by me. The Pageant System expressly disclaims all warranties of any kind, whether expressed or implied

## Miss Gay Texas State Pageant System Code of Conduct

As a representative of The Miss Gay Texas State Pageant System, in any form, you agree to the following guidelines for conduct.

- 1) I will not participate in harmful, malicious, inflammatory, defaming or slanderous speech towards the Miss Gay Texas State Pageant System, it's Board of Director members, promoters or sponsors, whether it be oral, written or otherwise conveyed
- 2) I will remember that my Facebook page content and photos, or any other social media sites (Twitter, Instagram to name a few), website(s) or web page(s) is considered a reflection on me and the Miss Gay Texas State Pageant System. Examples of such material include but are not limited to:
  - a. Text or Photos which is insulting to an individual or group of individuals.
  - b. Text or Photos which contain foul language, explicit and/or inflammatory comments; that would cause harm to yourself or others
- 3) Never demean the pageant or title they represent.
- 4) Never cause substantial problems for their promoters or for those for whom they perform.
- 5) Never become intoxicated or under the influence of drugs while representing their respective title.
- 6) Never participate in any type of argument or altercation, except as a mediator, while representing their title.
- 7) Attempt to solve any problems with Promoters and/or co-performers in a peaceful manner and in good faith. Problems may be mediated through the Board of Directors of The Miss Gay Texas State Pageant System. All complaints must be documented in written (typed) form for opinion/official mediation from the Board of Directors of The Miss Gay Texas State Pageant System.
- 8) Never lecture the audience or use profanity, only provide quality entertainment.
- 9) Any titleholder and/or 1<sup>st</sup> alternate who conducts a fundraiser under the MGTSPS umbrella and fails to attend the state pageant must release all funds to the MGTSPS or be subjected to a 1 year ban from the MGTSPS.
- 10) Violating the Code of Conduct for Titleholders may result in the disqualification/revocation of the title and/or jeopardize the winner's/first alternate's standing with the Board of Directors of The Miss Gay Texas State Pageant System. The Board of Directors of The Miss Gay Texas State Pageant System shall make final decision for any warning or revocation of any titleholder or qualification position, on any level.
- 11) Violation of the Code of Conduct by any other representative will be handled by any member of the Board of Directors as deemed necessary, according to the bylaws.

## Miss Gay Texas State & Miss Gay Texas State at Large Agreement

- Initial \_\_\_\_\_ 1. Be an active member of the BOD. This includes attending all meetings, carrying your pageant manual with you always including but not limited to meetings, prelims, and any fundraising events.
- Initial \_\_\_\_\_ 2. Attend and participate in ALL prelims AND fundraising events. This includes all fundraisers produced by the BOD. Should you have ANY conflicts it must be approved by the BOD.
- Initial \_\_\_\_\_ 3. At a minimum, produce two (2) benefits during your reign. One (1) benefit must be completed within first six (6) months of your reign, with the second benefit should be done 3 months prior to the state pageant.
- Initial \_\_\_\_\_ 4. Your cash winnings will be disbursed throughout your reign as follows; \$200 at upon winning, \$200 after your first completed benefit, \$200 after your second completed benefit, \$200 when you step down at the state pageant.
- Initial \_\_\_\_\_ 5. You will be responsible for acquiring a minimum of \$200 in ads sales and assisting others with advertising for state program.
- Initial \_\_\_\_\_ 6. Within thirty (30) days of winning your crown, you MUST present to the BOD your plan of action for your reigning year. You must present your working plan of action at each BOD meeting during your reigning year.
- Initial \_\_\_\_\_ 7. Know all promoters and contestants in the pageant system and assist them as needed. Mentor the contestants as one of them will be your successor.
- Initial \_\_\_\_\_ 8. You are the FACE of the Miss Gay Texas State Pageant System, and we will promote you to the best of our ability. However, you must always represent the pageant system during your reign. This includes acknowledging the pageant system any time you perform, at any venue, for any reason. Anytime you are representing the pageant system you must wear your crown and/or sash. You are required to supply the BOD your crown headshot within 30 days of being crowned.
- Initial \_\_\_\_\_ 9. At any time, there is an issue, there will be an investigation. If you are at fault for violating the By-laws, Rules and Regulations, and/or Code of Conduct you will be disciplined as follows:
- a) 1st violation - verbal warning
  - b) 2nd violation - written warning
  - c) 3rd and final violation - removal of crown and title. All winnings including money, jewelry, and sash must be returned in the condition it was received, to the BOD within 72 hours.

The newly crowned Miss Gay Texas State and Miss Texas State at Large will be required to uphold these requirements as well as the Rules and Regulations, By-laws, and Code of Conduct.

## **Prelim Pageant Rules and Agreement Applicable for Prelim and State Pageants**

1. All contestants **must be biologically male** and have no breast implants, hormone enhanced breasts, cosmetic or body enhancing implants below the neck and be at least 21 years old prior to the preliminary competition. Proof of age, such as a driver's license and/or state issued identification card, passport, must be provided if requested. If no validation is presented, the contestant will be disqualified.
2. Contestants that wish to run for an At Large preliminary must be at least 6ft tall (out of heels) and/or at weigh at least 200 pounds. and adhere to Rule #1.3. Contestants will be judged in the following categories: Presentation, Personal Interview, Evening Gown, On Stage Question & Answer, and Talent.
3. Judging will be based on a total points-accumulated system. In the event of a tie, the winner will be determined by the highest talent score. If there is a tie in the talent scores, the tie must be broken by an onstage question involving the top 2 finalists.
4. Presentation theme will be determined each year by the current state titleholders.
5. Talent performance will be limited to 7 minutes, with an additional 2-minute prop set up, and 2-minute prop tear down allowed. Presentation and Evening Gown will both be limited to 2 minutes, and Interview limited to 7 minutes. Props for presentation are allowed only if brought on and off by the contestant with no additional set up time.
6. Contestants should consider their talent appropriate for all members of the audience. Talent shall not cause harm or injury to contestants or others or contain offensive content. Use of projectile props is prohibited. (Direct any questions to current titleholders.) NO PYROTECHNICS are permitted (fire, flash pots, flaming batons, etc.). The use of real or authentic looking weapons is prohibited. Liquids of any nature are prohibited. Fog machines, if used, must be provided by the venue only. Any containers used must be dry. Any containers that have labels related to "Alcohol" must be cleared through the facility owner prior to entrance. This relates to TABC rules. All items used in any act must be cleaned up immediately or administrative points will be deducted from the overall score.
7. Contestants are to wear an evening gown appropriate for the crowning ceremony.
8. Each contestant will be permitted one (1) assistant in the dressing area at any given time and will be required to have a pageant issued badge. Only one assistant may be admitted at no charge, all other dressers, dancers, talent performers and all others must pay any door admittance fee. Dancers will be allowed backstage to prepare 2 numbers prior to their performance.
9. All Winners and 1st Alternates MUST compete at Miss Gay Texas State Pageant. Any Winner who does not compete at Miss Gay Texas State Pageant may be banned from the System for one (1) year and will not be permitted to be involved in any Miss Gay Texas State Pageant functions or preliminary pageant held during the year, at the discretion of the BOD. All prizes including, but not limited to, cash, crowns, and awards must be returned to the promoter. Any preliminary winner who is unable to attend the state pageant due to work or health restrictions MUST notify their promoter and BOD a minimum of 30 days prior to the state pageant. The Miss Gay Texas State Pageant System is not responsible for any agreement between the promoter and contestant.
10. The abuse of controlled substances or the dispensing of any controlled substances will not be tolerated. Should any activity occur, the individual will be immediately dismissed and any "state title" may be removed by action of the Executive BOD. Any two (2) Executive Board Members may act on behalf of the board in its entirety.
11. Excessive use of alcohol to the point of perceived "public intoxication" or any inappropriate conduct will not be tolerated. Any two (2) Executive Board Members may act on behalf of the board in its entirety. Any further offenses will be handled on a case-by-case basis with reprimand executed by the BOD up to and including removal of title.
12. Any contestant or their affiliates caught in the act of stealing and/or causing damage to another contestant's property will be immediately disqualified and removed from the pageant location.
13. All former titleholders in violation of rules #3, #4 and/or #5 regarding controlled substances, public intoxication and or theft at any state function who have already been reprimanded and are in violation of those rules can be subject to being banned from the pageant system.
14. Anyone, including contestants and their affiliates, who cause a disturbance of any kind during a preliminary pageant or at the Miss Gay Texas State Pageant may be disqualified or have administrative points deducted, and could be banned from all future events. We expect all contestants and their affiliates to behave in a professional manner. Any two (2) Executive Board Members may act on behalf of the board in its entirety.

15. Smoking, food, or drink will not be permitted in the dressing areas at any pageant competitions.
16. Anyone, including, but not limited to contestants, assistants, dancers, etc. caught badgering, harassing or belittling any contestant, any judge, any member of the Miss Gay Texas State Pageant System or any affiliates may be immediately disqualified.
17. Contestants must compete at the State pageant in the division they competed in at the preliminary. Winners of a preliminary may not compete in another preliminary during the current pageant season. 1<sup>st</sup> Alternates are permitted to compete in another preliminary, if they so choose, with the understanding that they forfeit their first alternate status and cannot reclaim it.
18. The current/ reigning Miss Gay Texas State and State At Large winner may not hold or seek other titles during the reigning period. After their reign winners of the Miss Gay Texas State and State At Large pageant will be permitted to run in another pageant system of their choice after their step down within 18 months (not to exceed \$125.)
19. The Miss Gay Texas State Pageant System is not liable for personal fundraising of any titleholder and/or 1st alternate who conducts a fundraiser under the MGTSPS umbrella and fails to attend the state pageant must release all funds to the MGTSPS or be subjected to a 1-year ban from the MGTSPS.
20. If at any time there is an issue, there will be an investigation. If you are at fault for violating the By-laws, Rules and Regulations, and/or Code of Conduct you will be disciplined as follows:
  - a. 1st violation – verbal warning
  - b. 2nd violation – written warning
  - c. 3rd and final violation – removal of crown and title. All winnings including money, jewelry and sash must be returned in the condition it was received to the Board of Directors within 72 hours.
